and they too, reported seeing it,, This
sighting was the second day of the deer
season. I spoke of this to a Highway
Patrolman, "in Reason" He looked
funny & puzzled. & said, it must have
been a Kusters glare, I left it, at that

Air Force. & they couldn't tell me of

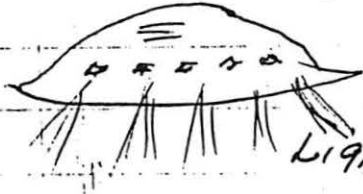

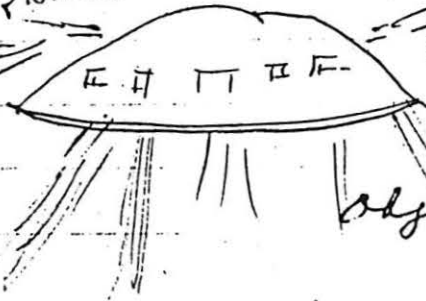

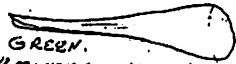
