was impressed but said no one believed her - my oldest daughter first denied and then said yes - she remembers - my son in law doesn't believe in phenomena - so he denies it - now after all these years my oldest daughter says "if" she saw it she can't remember.

My youngest daughter and I had just about the same reaction - we saw it it was a good feeling - personally I wasn't surprised - it was as if I had seen it before - I had a warm safe feeling in its presence - but there is one thing that confuses me - it seemed to go on for at least a half of an hour - a trance like feeling - an out of body sort of feeling. I've had many dreams after for a few years (3 or 4 yrs) that I was on the ship itself it had stairs leading to a second platform. I loved being in it but always worried about coming home - because it was like (I imagine) taking off in a rocket or rather spacecraft. It was like as if I belonged and didn't really want to come back - I was a part of the group - very loving.

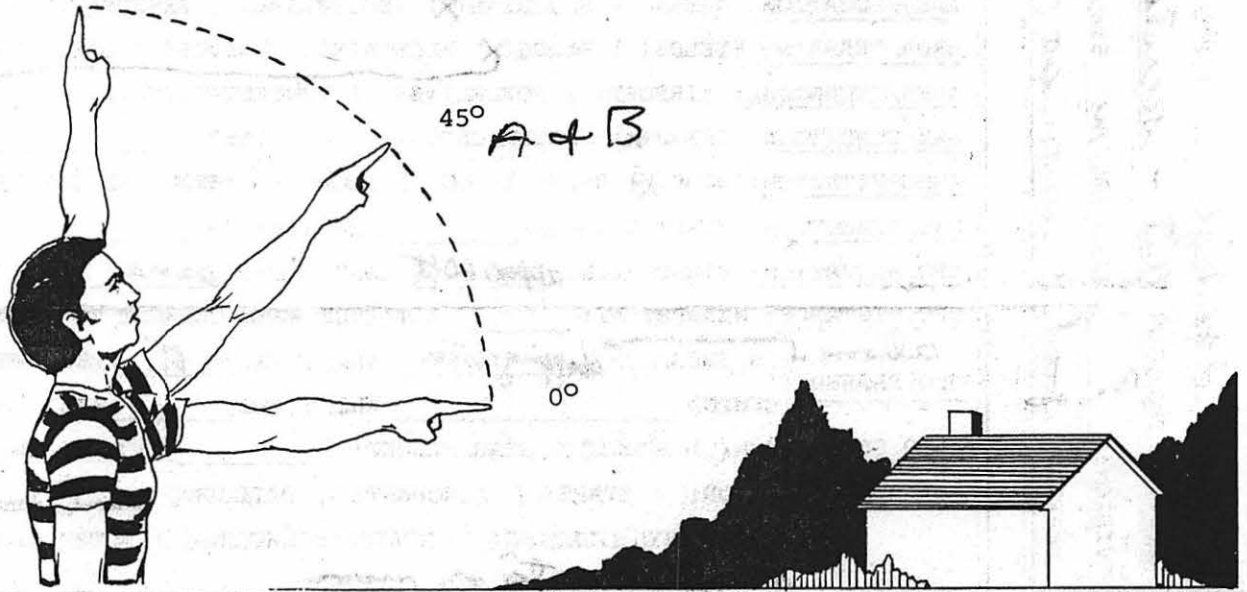

DRAW IN THIS PICTURE HOW BIG THE UFO APPEARED COMPARED WITH:

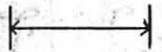
