Gentlemen:

First of all allow me to say "Thank You" for answering my correspondence concerning a U.F.O. sighting my daughter and I had in 1978. As I explained in my original letter, we did not report it to any agency at the time, because of fear of publicity and investigation. With time, however, and other experiences, I find it urgent to tell someone about our experience. I was more or less indifferent to the topic of U.F.O.'s prior to the sighting, but I was never unbelieving. I just never thought that I would be able to have such an opportunity. Since that time. we have had other sightings and other experiences. Recently, when I saw a Dr. who works at the Center for U.F.O. Studies in Evanston, on the John Davidson TV show. I knew that I just had to tell someone. Especially when he showed a sketch of the most common type of humanoid form seen close to sightings. In February of this year, I saw which a type emerging from an abandoned house almost directly in front of my house . It was about 9:00 p.m. on a moonlit night. He was short with a head that was too large in proportion to his body and his body emitted a greenish light that followed his form wherever he went. When he descended the nath from the house to the highway, he disappeared in thin air right at the point where the path joins the road.

As I explained in the form enclosed, directly behind our house is a large hill--P.R. is hilly. It is mostly treeless except for the tip there where there are many trees, with a clearing in the very center of the trees. That is where I first saw the U.F.O., plus many "night lights" since that time. That hill has a long and somewhat unclear history of

many unusual and suspicious happenings, many of these we have actually seen with our own eyes, and experiences we have actually seen with our own eyes, and experiences we have actually seems had. Some friends and myself have had what we believe to be telepathic messages or whatever you want to call them. So far, we understand that we are unexperienced in such matters, since we just recently became interested in these things, since these sightings began in this area.

What I would like, first of all, is to have this kept in the most extreme confidence, I don't want any publicity or investigation, What I DO want is information and help from someone who has had the same kind of experience I have had. Like I said two years have passed since my first sighting, and I never reported it because of the fear of publicity, people calling me "crazy"or something, even though my daughter did see it also. Since then we have had other experiences, but nothing like that "first time". I would like for someone to write to me, telling me what I should do from here on out. I am writing around here in Puerto Rico also to see if there is a center for the study of U.F.O.'s here. There should be, if there isn't. If there is, I am soliciting their cooperation also. I didn't get a picture yet, because I want to get an instant camera first, not to have to send in film to be developed and take the chance of losing the picture forever. I hope sincerely that you can be of help to us. I think this is a very important matter. The U.F.O.'s are here for a purpose--well you know that already. I will be awaiting very anxiously your reply, and, I hope, your assistance. Thank you so much for just listening.
