 Suddenly P.G. ^{Paula Culler} got up, went to window, stood there, riveted, totally charmed.

P.G. said "Something weird out here. Looks like a saucer, stands still, jumps to other spot."

D.G. came, looked, could not see it. P.G. said it went behind cloud, did not re-emerge. ^{P.G. said "How can you not see it, it's right there above the telephone pole!"}

D.G. grilled P.G. for at least 2 hrs. P.G. did not want to talk about it, but did.

P.G. convinced P.G. to call JAH next day who said ^{later} she had called him at Ctr, and that he had told her that "You're from the Grand Cities, right?" ("yes") It appears to have been the same object that was seen in Ohio.

WITNESS ACCOUNT (CONTINUED)

"To best of his knowledge, it sounded like a UFO."

(more conversation on tape)

and also that 60-70 people had called in from Quad Cities, some reporting object in eastern sky, some in western sky.

No one else (that they knew) reported anything.

App: Seven-like, in lights around ^{pulsing} ~~and~~ sequence, but when it moved (jerkily) lights flashed out of sequence.

What difference from old plane? - "one row, ^{PC} could see that there were lights on other side. ^{straight} Clear sky - no other traffic, but soon after object disappeared, other planes did appear. (behind cloud.)"

"It moved S-N, so fast that the eye could hardly follow it. PC thought of various possibilities, finally concluded it was unknown."

"She said there was a sense of 'Look at me!' why not plane - Different pattern than plane lights. UFO → ^{Shallow semi-circle} ○○○○○○ flashing faster than lights of plane"

They spent several hours watching plane lights and comparing them to object. O had almost halo effect after.

They had feeling they had been played with - in that D6 (male protector) had been excluded from an intense personal experience.
