"To best of his knowledge, it sounded like a UFO."

(more conversation on tape)

and also that 10-70 people had called in from two cities,  
some reporting object in eastern sky, some in western sky

No one else (that they knew) reported anything.

Abt: Saucer-like in shape round with, <sup>Palacing</sup> flashing on-off  
and sequence, but when it moved (jerkily)  
lights flashed out of sequence.

What difference from ad plane? - "one now," could see that there  
were lights on other side. <sup>almost</sup> Clear sky - no other traffic,  
but soon after object disappeared, other planes did  
<sup>(thin cloud.)</sup> appear.

"It moved S → N, so fast that the eye could  
hardly follow it. At thought of various possibilities,  
finally concluded it was unknown.

"They said there was a sense of "Look at me!"  
why not plane - Different pattern than plane lights  
UFO → <sup>Shallow semi circle</sup> "oo ooo ooo" flashing faster than lights of plane  
They spent several hours watching plane lights and  
Comparing them to object. O had almost halo effect  
after.

They had feeling they had been played with - in that DG (male  
protector) had been excluded from an intense personal experience.
