Gentlemen:

I believe in UFO's as beings from either our inner planet or outer galaxy beings. I was really reluctant to report any such sightings for the usual reason of not wanting to be classified as a "lunatic". However, after attending a lecture by Dr. Hynak at the Broodmoor Auditorium in Baton Rouge, Louisiana, and he telling us that it was our "duty" to report any UFO experience that we had, no matter what we felt about it, I decided to.

I had read or heard, I can't remember which, that some UFO's were "helpers" to us.

I had to go to Pensacola, Florida one weekend, several years ago, when I had this experience I am about to explain to you. We took the gulf route because I love the beach, especially at night, which is when we were traveling.

Myself, Linda Martin, a friend, and my son, Martin Fisher, were in the car. We left about 9:00 that night. Somewhere just past Slidell, Louisiana, I missed my turn. So I came to a stopsign where we just sat. Just joking with Linda, I said that I believed that UFO's were angels and that if we asked we might get one to help us out here.

All of the sudden, a light came from the sky, toward our car and down far enough that we could see that it was not an airplane or a star. We could see something like the dome ship that we have seen pictures of. When it came toward us we became a little frightened but did nothing but watched it. After it came down to let us know it was there, it went to the right very slowly.

Just for the fun of it, because we did not believe that it was really a space craft, we followed it to the right. Within a half of a mile we saw our road sign and we were not only on the right road but going the right way. We were amazed to say the least. We were even more amazed when it stayed right straight in front of us.

As we came to the gulf we saw something emerge from the waters that was at least 10 feet long, or more, because we were quite far from it, with red lights that looked like it encircled it.

The ship was still in the sky and the craft was still in the water. The one in the water acted as though it were following us too. We would slow down as the cars passed us and it would be right at our right hand door, continually. No matter what we did, it was still there. As we moved, it did. We even stopped

on the beach and got out of the car to see if it would go away, but it didn't. To me it looked like a long barge. There was no top to see, just the red lights that went around it.

The ship in the sky would go in and out toward us and away from us to let us know it was still there, but it did not go away either. This went on with the two crafts all night, until the sun came up. Then the ship in the sea went under and the craft in the sky came in for one last goodbye and then went out into the sky to look like a star then went out into the universe, it completely went away. This occurred in Pascagoula, Mississippi.

Through all of this not one of us felt really uneasy. We were amazed by what had happened to us but nothing really frightened us. In fact, we felt quite secure as long as these ships were with us.

I know this sounds ridiculous, but this is exactly what happened. Just to let you know that I am not a nut, let me give you some credentials. I am a Stenographer for the Department of Labor, working for the Attorney for the Department of Labor and the Chief Investigator. I have been a Rosicrucian since 1969 and am on the Board of Directors for the Louisiana Society for Psychical Research, as well as the Chairman for the Investigations of Phenominal Happenings that occur in the homes of people, Wife and Mother.

There have been other siteings that have occured. Such as, again Linda was with me, as we were driving toward Zachary, Louisiana, just out of the side of the eye, I could see lights, it has been so long, I really don't remember the colors, but I know there were several and one was blue. Just as soon as I turned my head to look I could see a huge ship and I did get a good look at it. It seemed to know that I saw it because as soon as I did it zoomed off at a 45 degree angle and within 2 seconds it was looking like a star in the sky. It never made a sound. This happened behind a shopping center in Baker, Louisiana.

My husband and I own a home in Baker with 3 acres of land, a barn, pasture, etc. One evening around eight o'clock, my husband came running into the house. He had seen a red glow just behind the barn. At that time we had horses and they were really cutting up just as our dogs were. He did not go back to see what it was because he was afraid. He said he had a very uneasy feeling about the light and just wanted to come into safety.

My husband and I went on a trail ride in Walker, Louisiana in 1975. As we came to a creek, which our horses had to swim to get across, we all heard a monstrous sound. It was comming from the woods but no one had ever heard anything like it. I know it was not one of our wild animals, because the owner of the land seemed to know all about it, but, when I asked he asked me not to say anything in front of the rest of the people. All of our horses started rareing and bucking and kicking. One rider got kicked in the leg by one of the other horses. The horses were terrified. And so were we. I thought I would never get out of there. This was one of the areas that the "Big Foot" was reported in about 2 months later.

I understand that siteings are not rare. I also believe that we are not alone, but, how would other people feel about that?
